

Underserved communities are communities that have (1) limited access to affordable, healthy foods, including fresh fruits and vegetables, in grocery retail stores or farmer-to-consumer direct markets; and (2) a high rate of hunger, a high rate of food insecurity, or a high poverty rate.

Agriculture, and Horticulture

The bill requires states to use such funds for loans that support grocery stores in underserved communities, including for opening a store (excluding new construction), or supporting an existing store.

In order to qualify for loans, grocery stores must meet criteria enumerated in the bill. For example, grocery stores must (1) emphasize unprocessed, healthful foods; (2) provide staple foods and a variety of raw fruits and vegetables; and (3) charge affordable prices at or below market values.

Further, states must prioritize loan applications from entities that meet criteria related to hiring workers from the underserved community, providing classes or educational information about a healthful diet, sourcing food from local urban farms and gardens, or demonstrating existing supply chain relationships or expertise in the grocery industry.

families when determining the work participation rate.

Specifically, the section requires that states must provide those families with a benefit of at least \$35 per month (funded with state expenditures) in order to count the families when determining the work participation rate.

(Sec. 304) This section requires states to report metrics related to the employment and educational outcomes of individuals who exit the TANF program. Specifically, states must report on the employment rate for individuals in unsubsidized employment following their exit from the program and their median earnings. Additionally, states must report on the percentage of individuals under age 24 who obtain a high school degree or equivalent while in the TANF program or within a year of their exit.

(Sec. 305) This section makes the changes to the TANF program generally effective on October 1, 2024. However, changes affecting the caseload reduction credit and the provision of limited TANF assistance are effective on October 1, 2025.

TITLE II - SNAP EXEMPTIONS

(Sec. 311) This section expands applicability of the work requirements for SNAP recipients who are able-bodied adults without dependents (ABAWDs). (SNAP recipients who are ABAWDs have work-related requirements in addition to the general SNAP work registration and employment and training requirements.) Specifically, this section applies the work requirements for ABAWDs to adults who are

- not over 51 years old in FY2023,
- not over 53 years old in FY2024, and

 not over 55 years old in FY2025 and every year thereafter.
 Under current law, these requirements apply to adults who are not over 50 years old. These provisions go into effect 90 days after enactment and sunset on October 1, 2030.

Also, the section exempts from the ABAWD work requirements homeless individuals, veterans, and certain individuals who were previously in foster care and are 24 years old or younger.

(Sec. 312) This section prohibits a state agency from accumulating unused exemptions to the ABAWD work requirement and providing them to eligible SNAP recipients beyond the subsequent fiscal year.

Currently, for each fiscal year, a state agency may exempt a certain number of SNAP recipients from the ABAWD work requirements; unused exemptions may be carried over and used in a subsequent fiscal year. Under this section, an unused exemption may not be carried over for more than one year.

Further, this section reduces the percentage of exemptions a state agency may provide each year so that the average monthly number of exemptions does not exceed 8% of covered individuals (i.e., SNAP recipients and certain individuals who were denied SNAP benefits due to the work requirements). Under current law, a state is eligible for exemptions for up to 12% of covered individuals.

income adults in obtaining employment and increasing their earnings.

(Sec. 314) This section requires USDA to make public all available state requests for waivers from the SNAP ABAWD work requirements and the approvals of the requests within 30 days of enactment; this includes making public all supporting data from the state about the request and relevant documentation on the utilization of waivers.

This waiver program allows the Food and Nutrition Service to provide a state exemptions from SNAP ABAWD work requirements based on a determination that an area (1) has an unemployment rate of over 10%, or (2) does not have a sufficient number of jobs.

S. 1188 Improving Digital Identity Act of 2023

Sen Sinema, Kyrsten (I-AZ) This bill establishes a temporary task force to recommend secure methods and coordinate efforts for digital identity verification (a process for verifying the identity of an individual who accesses a service online or electronically).

Specifically, the bill establishes a task force within the Executive Office of the President to coordinate a government-wide effort for promoting digital identity credentials (e.g., electronic driver's licenses and birth certificates) for use in the public and private sectors. This includes

- identifying the governmental agencies that issue identity credentials or hold information used to identify an individual;
- recommending a strategy for digital identity verification that addresses issues such as privacy, equity, and interoperability; and
- identifying funding or resources needed to support governmental

agencies with adopting digital identity verification.

Members of the task force include representatives from federal agencies; representatives from state, tribal, territorial, and local governments; and nongovernmental experts. The task force must periodically report its findings and terminate three years after the enactment of the bill.

Further, the Office of Management and Budget (OMB) must issue guidance for federal agencies to implement task force recommendations, and federal agencies must annually report on their implementation activities. Additionally, the OMB must report on the implementation and effectiveness of federal digital identity capabilities in coordination with the Cybersecurity and Infrastructure Security Agency. The Government Accountability Office must report on the potential savings from averting benefit fraud and identity theft by increasing adoption of digital identity verification
